## What information we collect

The information we may collect includes:

- your name;
- your phone number;
- your email address;
- details about your family, ancestor or claim group connection; and
- any other information you choose to provide through the registration form.

Information about your family, ancestor or claim group connection may be sensitive information because it may relate to Aboriginal identity, descent, family connection or cultural affiliation.

## Why we collect this information

Your information will be used for claim-related purposes only. This may include:

- confirming your registration for claim group meetings;
- sending meeting notices and updates;
- assisting with claim group communication;
- helping identify people who may need to be notified about native title meetings or processes;
- supporting consultation, authorisation and related native title processes; and
- supporting the preparation and progression of native title applications.

## Confidentiality

Your information will be handled confidentially. It will not be published on the website.

Massar Briggs Law will handle your information in accordance with its privacy obligations and its professional obligations as a legal practice, including obligations of confidentiality.

## Who we may disclose information to

---

We may disclose your information only where reasonably necessary for claim-related purposes, or where required or authorised by law.

This may include disclosure to:

- legal representatives and counsel;
- experts assisting with the native title matters;
- meeting organisers or administrators;
- the Federal Court of Australia;
- the National Native Title Tribunal;
- First Nations Legal and Research Services;
- other persons or bodies involved in the native title process; and
- secure IT, website, database or document management service providers used to store or manage claim-related information.

We will only disclose information where appropriate and for the purpose of progressing the native title matters.

### **If you do not provide the information**

You do not have to provide this information. However, if you do not provide it, Massar Briggs Law may not be able to send you meeting notices, updates or other information about the claim process.

### **Access, correction and removal**

You may contact Massar Briggs Law to ask for access to your information, to correct your information, or to ask that your details be removed from the contact list.

If your details are removed, Massar Briggs Law may no longer be able to send you notices or updates about meetings and other claim-related matters.
